## Member displays by Rick Kennedy

For the July meeting, we were treated to a very informative talk about Obsidian found in the Davis Creek and other areas up near the CA/OR border. People were asked to bring samples and boy did they show up!

To start out with Cecilia Fabos-Becker brought a number of samples of Davis Creek and Lassen creek areas. She also showed off a number of old field guides her father used to own. Randy Harris also brought a few of his smaller pieces (in other words, it only took one person to carry each piece) including a very nice piece of snowflake. Fred and Jo brought in one of the most beautiful Obsidian carvings I have ever seen, it was a sheen Obsidian with the relief of a butterfly and a heart carved perfectly to show off the sheen.

Rick Kennedy brought a number of new Benitoite specimens he has been etching. Larry Moore brought an impressive assortment of material collected between Succor Creek in Oregon and McDermit at the Oregon/Nevada border. There was plume agate, picture rock, petrified wood, green jaspers and dendritic agate, quite an impressive haul. David Marshall had some very nice samples of carved gemstones, learned by taking the class Ron Martinez offers.

Lisa LaRocca brought us a sample of Quartz and a great story about a major find of crystallized Lavender Quartz from the area near Truth or Consequences, New Mexico. Hidden in the number of member displays was Betty Pankey's handiwork: A beautiful Hummingbird that she made.

For the August meeting, Frank put on an excellent short workshop on displays. Hopefully everyone will come up with something for our show next year. It is a great way both to contribute to the quality of our show and to show off what we love!

June and Randy Harris brought a nice selection of different, highly displayable pieces that came from both their rock picks and their silver picks! 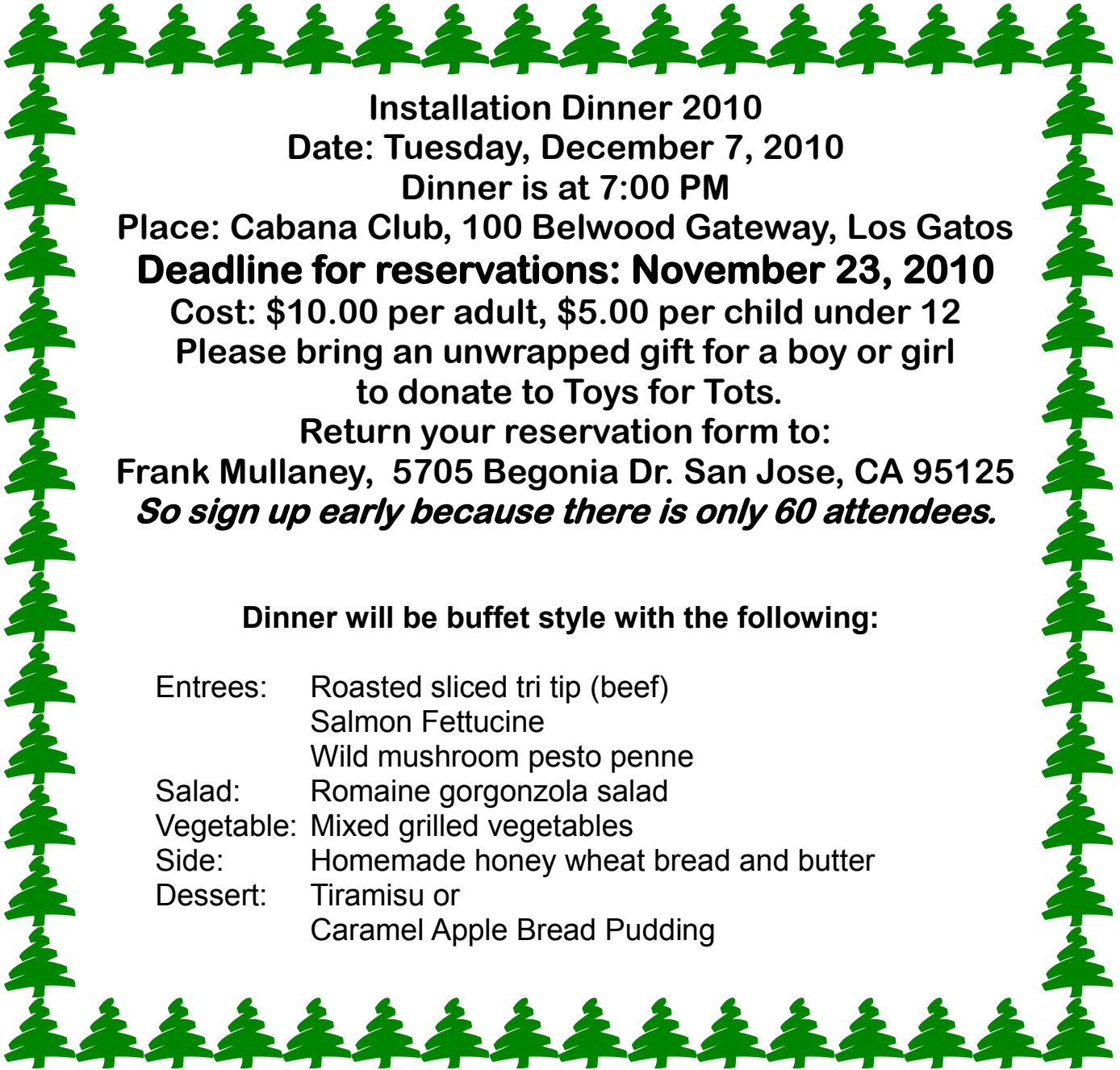

## SCHOLARSHIP PROGRAMS

As members of our Society we are participants in three different scholarship programs which are sponsored by the rock-hound societies. First we have the program which is part of our own Society activities. We offer scholarships as determined by our Board of Directors to local college or university geology departments. The students must be an earth science major in their junior or senior year and must maintain a minimum GPA of 3.0.

This year the SCVGMS Board has proposed to offer four \$1,000 scholarships to local colleges and the individuals to receive them will be selected by the geology departments in their respective schools. The schools to have students selected are San Jose State University, University of California at Santa Cruz, California State University East Bay, and Stanford University.

The second program, which we are involved with, is the California Federation Scholarship and these scholarships are offered to college students in their junior or senior year. The CFMS Scholarship Committee is responsible for selecting an Honoree or Honorees from the persons nominated by the Societies of the CFMS. The Honoree is to have made great contributions to the CFMS and does not have to be a member of a CFMS society. Any member society may nominate an Honoree and a Committee Chairman or the Federation Director of any Society may send the nomination. The Honoree is responsible for selecting a school to receive the scholarship and should participate with the school in the selection of the student to receive the funds.

At the present time the Chairman of the California Scholarship Committee is Jennifer Haley and her address is 5442 Washington St., Napa, CA 94558. We have had several persons from our Society who have been Honorees and have selected schools in our area. The latest one to receive this honor is Frank Monez who selected a student from San Jose.

The third program, which we work with, is the American Federation Scholarship Foundation. This is a separate corporation from the American Federation and was established in 1964 solely for the purpose of raising monies and presenting scholarships. Each of the participating Federations chooses an individual to be known as the Honorary Award Winner. This person is to have the privilege and obligation to select an Educational Institution in the United States to select students to receive a scholarship grant. The student (or students) selected are to be a postgraduate students studying for his or her Master's or Doctor's Degree in a division of the Earth Sciences.

All of the monies donated to either the CFMS or AFMS Scholarship programs are kept in a restricted account and the interest only is used for scholarships. At the present time the AFMS Scholarship has given over a million and a half-dollars in scholarships and the fund is close to a million dollars.

The California representative to the AFMS Scholarship is Betty Pankey and her address is 4310 Kingsley Drive, Pittsburg, CA 94565-6267.

Personally I am very proud of each of these programs and hope that you all feel we are doing a good bit for the future of our interests in earth sciences.

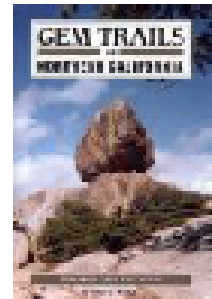

## CFMS PLAC South By John Martin New National Monuments and HR 5580

In February of this year an internal draft proposing the creation of over 19 million acres of new or expanded National Monuments under the Antiquities Act of 1906 was leaked from the Department of the Interior. Under the Antiquities Act of 1906, the President of the United States can use his executive order power and by-pass all of Congress to create national monuments. The leaking of this internal draft has led to a stir among congressional representatives across the entire country. These new or expanded national monuments are to be located in Utah, Montana, New Mexico, California, Nevada, Arizona, Oregon, Colorado, Washington, Alaska, and Wyoming. The estimated cost to taxpayers for the acquisition of private land within the proposed national monuments is approximately \$2,383,260,000.00 as reported in the internal draft. Many of these nationally significant landscapes are worthy of inclusion in a national monument system. However, the proposed method of creation of these national monuments has come under fire by many members of congress and has outraged many citizens across the United States. As far as rockhounds go, many of our collecting areas in these states would be included in these national monuments and thereby closed to future collecting. In June of 2010 fourteen members of congress drafted and introduced a House of Representative bill, to amend the Antiquities Act of 1906. This new bill will require that congress and the public have an input in the creation of any national monuments and to limit the power of the president's ability to create national monuments without concurrence of the congress. This bill **H.R. 5580: National Monument Designation Transparency and Accountability Act of 2010**, is only 9 pages long and deserves the support of all Rockhounds across our country. Please write to your elected officials and ask them to support this legislation. Help protect our recreational and collecting areas from arbitrary closures and special interest politics. ## A Bit About Opal

Excerpts from article by Richard Busch in Lithosphere, 05/95; via Opal Express, 9/06; via The Pegmatite, 11/06.

**Opal Lore:** Until three or four centuries ago, this stone was thought to combine all the virtues of various colored gemstones whose hues are united in its sparkling light; however, during the Black Plague in the 14th century, opal took on an evil connotation, as it was thought to lose its luster when its owner died of the plague. Opal is thought to be a good thieves stone in that it makes one invisible. It is also thought to preserve blond hair.

**Care of opal:** The fear of damaging an opal is not entirely fair to the species since no gemstone is indestructible. Opal is a bit softer and more fragile than most gemstones, but with proper setting and ongoing care, an opal can last a lifetime. Here are some tips. Generally, the thicker the opal, the better. Look for settings that protect the opal, such as bezel setting where the metal band holds the stone all the way around its edge. Prong settings should be avoided.

Because opals contain water, they are prone to drying out, which causes them to craze. Avoid storing opals in a bank safe deposit box. The atmosphere in bank vaults is purposely kept dry in order to protect papers. Unfortunately, this climate hastens the drying (and destruction) of precious opal.

**Buying and working opal:** When purchasing opal, it is best to buy from a reliable dealer and look for material that is at least one year old since, if the material was prone to crazing, it probably would have occurred by then. When working opal, keep the stone wet and cool to prevent it from shattering.
